Summary of progress for last quarter: (approximately 200 words)

Overall, the project continues to progress well. In this quarter, we have been undertaking the following pieces of work:

Scoping Review (In Progress)

We have submitted the Scoping review to the international peer reviewed journal Childcare In Practice. We anticipate that if it accepted by this journal, it will be published in late 2024.

### Programme Theory and data collection

We are making progress in finalising our programme theory and during this period we have held several sessions and workshops to test our initial programme theory (IPT). We met with the CASCADE Parents Group in early November, and they gave us some very helpful feedback on our IPT. In mid-November we held a very positive workshop, organised by Exchange, with over 40 participants (mainly social workers, managers, advocates and advocacy managers) to discuss our programme theory and get some useful feedback, which will feed into our finalised programme theory.

We are holding another similar workshop with Exchange to further test our IPT in early December and we are holding a final workshop with Social Care Wales in January 2024. These sessions will also help us to finalise our programme theory.

We continue to carry out interviews and focus groups in our three sites and have done several more interviews with parents and professionals during this period. This again has been very helpful in testing our IPT.

**Dissemination** 

- We recently had our narrative review on parental advocacy published in the Journal of Children's Services. <u>Devine, R., Benson, K., Fitz-Symonds, S., Westlake, D., Campbell, K.</u> and <u>Diaz, C.</u> (2023), "Peer parental advocacy: a narrative review of the literature", <u>Journal of Children's Services</u>, Vol. 18 No. 3/4, pp. 244-260. <u>https://doi.org/10.1108/JCS-08-2022-0020</u>
- We presented two papers on parental advocacy at the recent Kempe International Child Welfare conference, both of these presentations were very well received. We

also made links with other researchers and practitioners with an interest in parental advocacy from different parts of the world.

• We have submitted two abstracts on parental advocacy in Wales for the European Social Work conference which is taking place in April 2024. We have recently heard that one of the abstracts has been accepted, this will provide an important opportunity for us to disseminate our research to an international audience of social work academics and experts.

### **Objectives for the next quarter**

The focus for the next quarter is as follows:

- We will start to work on the final report for this project.
- We will continue to focus on dissemination activities in terms of presenting at conferences for practitioners, parents, advocates, managers, and academics.
- We are going to work with parents (in particular CASCADE's parents group alongside Dr David Tobis), practitioners, and advocates to develop practice guidance for Local Authorities and other organisations interested in developing and implementing parental advocacy services.
- We are working on two journal articles, one based on parental advocacy in Wales and one comparing peer parental advocacy with 'professional' parental advocacy.
